1. Expenditure under S137 Local Government Act 1972

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £ 0 under section 137. These payments are included within 'Other payments' in the Accounting Statement.




Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Seven Sisters Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- The Council has not met its obligation under the Local Government and Elections (Wales) Act 2021 to create and publish a training plan for members.
- I have been unable to complete my audit testing due to the inaccessibility of the Council's website

Arrangements to secure economy, efficiency and effectiveness in use of resources

In my opinion, the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources:

- The Council does not have in place standing orders for contracts as required by the Local Government Act 1972

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Publication of information

During the audit, we were unable to access information from the Council’s website due an error message stating “sevensisterscommunitycouncil.org’s server IP address could not be found.” We sought to access the website from a variety of devices.

We recommend that the Council reviews its website to ensure that it remains publicly accessible.

Accounting Statement: Reconciliation to underlying accounting record

We were unable to reconcile lines 4 and 6 to the underlying spreadsheet. As recorded on the accounting spreadsheet salary costs total £29,090 compared to line 4 which records £30,084. The total payments recorded on the spreadsheet matches that reported on the Accounting Statement.

We recommend that the Council provides a detailed reconciliation from the Accounting Statement to the underlying spreadsheet for future audits.

There are no further matters I wish to draw to the Council’s attention.
